An online Pre-Bid Meeting was held on 10.11.2022 at 03.00 pm through Google Meet, with prospective bidders to clarify doubts that may arise before submission of the bids in reference to the RFP for Design, Development and Maintenance of IIM Jammu New Bilingual Website and Associated Web Portals. The bidders had raised few queries for clarification. The corrigendum as under is for the information of the bidders.

Queries and Replies:

Query 1. Para 1.7, Page no 3- TARGET AUDIENCE OF WEBSITE

What access would Government agencies have on the portal? & How?

Reply: Government agencies are also the part of the target audience. Please refer to point 1.7 of the

RFP. No access will be given to any Government Agencies.

Query 2. Para 2.1.3, Page no 4.

Do we need to provide provision to update content for Multilingual form the backend portal?

Reply: Yes, A comprehensive "full function" multilingual CMS/web framework software solution that

includes, but is not limited to, template creation, security and approval levels, WYSIWYG

content editor, versioning, content scheduling, etc.

Query 3. Para 2.1.5 Page No 4

What are the Pain points of existing Drupal CMS?

Reply: The existing Drupal CMS is working with following configurations: Drupal 8.3.7, PHP 5.6.40,

MYSQL 5.6. Irrespective of this, technology for our new website and associated web portals is

mentioned at point no. 2.5 in RFP.

Query 4. Page No 2.1.8, Page no 4

Is multilingual support needed for backend admin panel as well?

Reply: No, It's not a mandatory requirement.

Query 5. Para 2.1.13, page No 5

Please explain the requirement of Hybrid model

Reply: It should be deployed on a hybrid model with the primary server on cloud and secondary server on premises, the development of the website must be hosted on a cloud-based platform and

must also be hosted and compatible with the hosting environment available on premises at IIM Jammu. This includes the staging and production environments. The scope of work includes the maintenance and migration of the DNS, all kinds of server administration of both cloud platform and on premises infrastructure. The cloud hosting charges will be borne by the Service Provider until the expiration of the Annual Maintenance Contract. The cloud hosting facility should

support auto scaling features for the infrastructure for peak loads. The cloud hosting model

should be based on Pay as you Go model. The proposed cloud service provider/data centre must be Tier III or above for better availability of cloud services. The cloud service provider should be empanelled with MeitY, Govt. Of India. The cloud infrastructure provided to IIM Jammu should be dedicated only to IIM Jammu and shall not be shared with any other client at any cost.

Query 6. Para 2.1.17, Page No 5

Does the main website/common web pages need moderator or approver system?

Reply: Yes, there is a provision of Content Contributor/Creator, Moderator and Approver System

wherein only authorised individual from IIM Jammu can upload the content their

department/respective domain on the website.

Query 7. Para 2.1.18, Page No 5- Data Migration

Reply: Service Provider shall carry out the Data migration /Porting of existing data into the new website. Migration of all content and documents from the existing Drupal CMS based website

into the proposed CMS/web framework-based website. Primarily the content on the existing website shall be migrated to the new website and new approved content to be displayed in the

website as provided by the Institute.

Query 8. Para 2.1.20, Page No 5

There are charges for STQC certifications, who will pay?

Reply: STQC charges will be borne by the successful bidder.

Query 9. Para 2.1.26, Page No 6

It is also required to integrate the Programme/Learning Management System with the website

so that imperative requirements.

Is LMS to be developed or to be linked

Reply: Yes, and LMS need to be developed for IIM Jammu

Query 10. Para 2.1.26, Page no 6

integrate the Programme/Learning Management System with the website

Please explain the whole section

Reply: The system should provide the complete lifecycle management of programmes (for example: registration, payment, engagement, etc.) related to conference, MDPs, FDPs, Training

Programme, Executive Education, and several academic programme. It should be amenable for customization, upfront maintenance and seamless scalability and also is economic from the academic viewpoint. Moreover, the need for ensuring accountability and closed monitoring IIM Jammu wants the system to be structured to have built-in access control and data capture mechanisms to make it fool proof. This enabled IIM Jammu in imperative requirements such as to facilitate rigorous teaching and learning through synchronous and asynchronous modes of content delivery. Numerous modes of instructions and the flexibility to use many pedagogies should be facilitated through the Programme/Learning Management System. The system should have the functionality of applying online, registering, enrolling & tracking complete lifecycle of the programme. The modules should have the platform for enquiry, download brochures of different programmes (MDP/FDP etc.) and designed to simulate conversation with visitors which help them by automated conversations and interact with them through messaging platforms. The web portal should include SMS, WhatsApp/Social Media notification integration, Email and Payment Gateway Integration. This platform will thus be enabling content authoring, content management and delivery. Online recorded sessions will enable equitable access by all students if they fail to attend the live classes. More detail of the above shall be provided during

the presentation.

Query 11. Para 2.2.3.7, Page No 7

Is payment gateway already integrated in existing website or associated web portal? If yes, can you please share the provider's name? If not, do you have any preference for provider?

Reply:

New Payment Gateway solution should be integrated which have minimum features like Robust Security, Responsive, adapting easily and quickly across devices, seamless One-Click Checkout, Easy integration with several modules, Accept all major debit and credit cards, UPI, net banking banks, popular wallets, and international transaction.

Query 12. Para 2.2.3.9, Page No 8

Design and Development of Web Application Devices having capability to connect directly to Service Provider's central system through laptops, handheld devices, mobile etc used for financial inclusion at grassroots level.

Please explain the whole section

Reply:

It should be accessible even on low bandwidth.

Query 13. Para 2.2.3.10, Page no 8

Developed Website Application should have multiple backend systems interfacing capabilities. Can you please provide more details on this statement.

Reply:

Multiple backends systems interfacing capabilities means that system should have different level of access rights like view, edit etc. Department level, admin/configuration panel should be available in the system. System should be able to incorporate new interfaces with different configurations.

Query 14. Para 2.2.4.7, Page No 8

Please explain the term "Mobile based application". Do you mean the web application to be developed should be mobile friendly or a separate mobile application?

Reply:

Yes, the website should be mobile friendly and Separate Mobile application needs to be developed by successful bidder.

Query 15. Para 2.4.1.3, Page no 10

Does it indicates the development of admission system also, part of this tender.

Reply:


Yes, Program Management System should provide complete lifecycle management of programmes. Admission Module is already part of RFP.

Query 16. Para 2.4.1.4, Page no 10

How access to right user is given on the website? For example - how we will identify student of IIMJ is accessing the platform? If it is going to be through SSO, does this mean our new system will have entries of those users in database?

Reply:

IIM Jammu Students can be identified by their respective cloud identity or Google Workspace account. (Domain Specific). Purpose of SSO is to eliminate password fatigue, Easier and faster logins to various modules (web application).

Is on-going SEO part of the website maintenance?

Reply: Ye

Query 18. Para 2.4.1.15 Page No 11

Does the current site have any online payment gateway integration? If not, please list down the pages / modules that need to have online payment facility.

Reply: Currently, IIM Jammu is using the Easy Collect Multi Modal Payment Portal (provided by J&K Bank Ltd.). New Payment Gateway Integration is required in various modules for IIM Jammu but not limited to admission, recruitment, placement, MDPs, FDPs, Conferences, Seminars, Accommodation, Fees collection, etc.

New Payment Gateway solution should have minimum features like Robust Security, Responsive, adapting easily and quickly across devices, seamless One-Click Checkout, Easy integration with several modules, Accept all major debit and credit cards, UPI, net banking banks and popular wallets, international transaction.

Reply: The website should comply with Web 3.0 technologies and W3 validated HTML and CSS.

Provide contact forms to get in touch with different stakeholders of the institute. Can you please

provide more clarity on this statement.

Reply:

Website should have short web-based forms so that any visitors can fill out the forms and submit it to send a message to the respective department of IIM Jammu.

Query 25.

Para 2.8, Page 19- INDICATIVE LIST OF REQUIRED FEATURES FOR THE ASSOCIATED WEB PORTALS:

Recruitment module, Placement module, FDP/MDP incubation module, Programme management system, Master form, Library, Tender module, Grievance, Ticket management.

Do these modules to be developed from scratch.

Reply:

Yes

The successful bidder shall bear the cost for the bulk SMS services as per the requirement of IIM Jammu.

This Mentor Mentee Module should be as a platform for aspiring students to communicate with the student/faculty of IIM Jammu. This may be both forum and live chat. Preferably through Forum facility.

Reply:

Recruiters will first register themselves and then go through the student data/profile/analytics to recruit prospective students. The placement module should have a dashboard to manage the student data/ profile/analytics/upload the student information in bulk including the photos/video/resumes/any other media.

Reply:

Yes, platform should be able to access through an android / iOS app - customized for IIM Jammu -made available in Play Store and App Store.

In library module, with whom user can chat here? What is purpose of chat service here?

Reply:

The purpose of the chat services here to help users to navigate library e-contents, feedback, widget etc.

Reply: The purpose of the events calendar in library module is to provide additional useful functions

related to events/activities based of the library.

Reply: Appointments allow doctoral study or dissertation students to have one-on-one sessions using

any collaborative tool with library officials in order to brainstorm and develop effective research

strategies for their dissertation or doctoral study literature review.

Reply: The service provider must provide a proper mechanism for automatic regular backup of the

backup.
