
update regarding the fast-paced construction activity nearing completion.



Rambabu Lavuri. Havocs of social media fake news! Analysing the effect of credibility, trustworthiness, and self-efficacy on consumer's buying intentions DOI: https://doi.org/10.1080/0965254X.2023.2253801

Abstract: The purpose of the study is to examine the influence of social media factors (credibility, trustworthiness, source credibility and self-efficacy) on consumer buying intention towards the branded product, with mediating (brand trust) and moderating effect (Persuasion knowledge) using Uses and Gratifications Theory. A total of 512 original samples were collected through purposive sampling methods and analyzed through structural equation modelling. The results reveal that credibility, trustworthiness, source credibility, and self-efficacy significantly impact brand trust, and trustworthiness, credibility; While self-efficacy played a significant role in the social media news to build strong brand trust. The brand trust had a positive and a robust mediating effect on consumer buying intention; and Persuasion knowledge positively moderates' credibility, trustworthiness, source credibility, self-efficacy and consumer buying intention. This study provides important implications from marketing perceptive as it applies and extends the gratification theory and persuasion knowledge. Our findings are beneficial for key stakeholders of a brand that are facing serious advertising concerns due to widespread fake news.

Praveen Kumar. How does Corruption Affect Innovation? - New Evidence from Macro-level Data DOI: https://doi.org/10.1007/s40953-023-00362-x

Abstract: This article explores the connection between a country's corruption-related risk exposures and innovations. For this purpose, I performed two fixed-effects panel-data regression models by utilizing Research and Development (R&D) expenditure as a dependent variable and absolute corruption scores & degree of corruption-related risks exposures as independent variables in the presence of five control



variables for 2019–2021. The corruption scores & degree of corruption-related risk exposures were collected from the Risk Indexes database. Data related to other variables, such as R&D expenditure, Industry structure, Energy Prices, and Urbanization levels, were fetched from the website of World Bank indicators. Further, the Population data were obtained from the worldmeters database. Consistent with the Sand-the-wheels theory, this research found that the country's high corruption-related risk exposures negatively influence innovations. On the other hand, the lower degree of corruption-related risks boosts innovations in an economy. This study provides policymakers with significant implications of the country's corruption-related risk exposures in the best interests of the world's stakeholders.

Praveen Kumar. Bitcoin Versus Gold Prices: Correlation or Mis-specification DOI: http://ubplj.org/index.php/jpm/article/view/1975

Abstract: Bitcoin is a newly created currency, which is also considered as "Digital Gold." Whereas, Gold is a precious yellow metal. Bitcoins are more independent of the government than gold. Both gold and bitcoins are scanty resources, and thus, prices of both these assets appreciate or deteriorate depending on the demand and supply. An attempt was made to examine the association between prices of these two currencies. For this purpose, three different models were run: independent sample t-test, correlation analysis, and regression analysis. The outcomes of the independent sample t-test revealed that there exists a significant difference between the gold and bitcoin prices. However, the findings of correlation analysis show that movements in gold prices are statistically and positively linked to bitcoin prices. These findings indicate that gold prices move in the same direction as bitcoin prices. Further, the results of regression analysis also depicted that movement of bitcoin prices depends on movement of gold prices. Since its genesis, bitcoin prices have experienced around 37,418 appreciations, which make it an extraordinary currency. However, this study argued that bitcoin is establishing itself as an investment asset for the short term only because fluctuation in prices is very abnormal and unreliable in the long run. Moreover, robustness checks further show that gold prices are increasing at a steady rate, but increments are regular and trustworthy. Finally, the study found that bitcoin provides much higher returns to investors than gold. These results are crucial for the risk-taker investors who are looking for higher returns because bitcoins are getting growing public exposure day by day and attracting investments throughout the world.

Praveen Kumar. Does IFRS convergence affect the readability of annual reports by Indian listed companies? DOI: https://doi.org/10.1108/JAAR-10-2022-0284

Abstract: The purpose of this study is to investigate the influence of IFRS convergence on annual report readability in an emerging market context, with an emphasis on the contents of management discussion and analysis (MD&A), notes to the accounts (Notes) and the whole annual report.

Design/methodology/approach: The study performs firm-fixed effect regression on a sample of 143 Indian listed companies over a period spanning from 2012 to 2021 to examine the influence of IFRS convergence on readability. This assessment primarily focuses on broader spectrums of readability dimensions, namely annual report length and complexity, wherein complexity is measured using the Gunning Fog, Flesch Reading ease and Flesch-Kincaid grade index.

Findings: As Indian firms shift to IFRS reporting, the findings suggest that annual reports have become significantly lengthier and more complex, causing deterioration in readability. The Notes section, in particular, exhibits the most significant increase in length and complexity, followed by the entire annual report and MD&A section. Furthermore, the findings also indicate that the complexity of the Notes section is instrumental in the observed complexity growth of the whole annual report in the post-IFRS period.

Research limitations/implications: The current study employs readability indices rather than directly taking into consideration the opinions of actual users of annual reports to determine readability. As a result, the study does not provide direct evidence on how information in annual reports affects users' readability.

Practical implications: The findings provide insightful information to managers and policymakers about the difficulties stakeholders may encounter while reading IFRS-based annual reports, which ultimately impact their investment decisions. Thus, there is an important managerial implication from this, depending upon the severity of complexity corporations participate in while complying with IFRS in the post-IFRS period.

Originality/value: Analyzing the influence of exogenous information shock, such as IFRS convergence, on readability is critical, particularly for emerging markets like India, where a lack of financial literacy and weaker enforcement already have detrimental effects on the capital market. In light of this, the current study provides a comprehensive examination of the impact of IFRS convergence on annual report readability and contributes to the growing IFRS literature in the less explored emerging market context.

Rambabu Lavuri. Unveiling ways to examine the purchase intension of green products in emerging markets. DOI:https://doi.org/10.1108/BIJ-06-2022-0379

Abstract: This research study uses the theory of planned behavior to investigate the factors such as environmental concern, perceived control behavior and subjective norms that foster green purchasing intention in the developing market, with the moderating influence of environmental knowledge.

Design/methodology/approach: Convenience and purposive sampling were used to obtain data from 418 respondents, which were analyzed using structural equation modeling.

Findings: The findings revealed that environmental concern had a significant impact on the subjectie norms, green attitude and perceived behavioral control; subjective norms had a positive impact on the green attitude, did not on perceived behavioral control and green purchase intention directly; perceived behavioral control had a significant impact on green attitude directly but did not green



purchase intention; green attitude had a significantly impacted the green purchase intention. Environmental knowledge had a strong moderation association between green attitude and green purchase intention.

Originality/value: The study explores the complex relationships between various factors, including environmental concern, subjective norms, perceived behavioral control, green attitude and environmental knowledge, and their impact on green purchase intention which can provide a more nuanced understanding of the drivers for sustainable consumption. Additionally, the study's finding on the moderating effect of environmental knowledge on the relationship between green attitude and green purchase intention may be a novel contribution to the existing literature.

Rambabu Lavuri. Role of virtual reality authentic experience on affective responses: moderating role virtual reality attachment DOI: https://doi.org/10.1080/14724049.2023.2237704

Abstract: The aim of the study is to examine the role of virtual reality authentic experience on affective responses (enjoyment, emotional involvement, and a flow state) towards visit intention in virtual reality with moderation of virtual reality attachment, using the stimulus organism response framework. Purposive sampling was used to collect primary data from 273 Indian sample. Results revealed that virtual reality authentic experience had a strong impact on enjoyment, emotional involvement, and a flow state. Similarly, enjoyment, emotional involvement, and a flow state had a positive impact on the visit intention of the respondents, and virtual reality attachment had a strong moderation relationship between the enjoyment, emotional involvement, and a flow state and visit intention. This research provides insight into the motivations of would-be visitors to visit VR-presented locations, and it will be helpful for tourism agencies and businesses looking to increase visitor numbers via virtual reality.

Rambabu Lavuri. Havocs of social media fake news! Analysing the effect of credibility, trustworthiness, and self-efficacy on consumer's buying intentions DOI: https://doi.org/10.1080/0965254X.2023.2253801

Abstract: The purpose of the study is to examine the influence of social media factors (credibility, trustworthiness, source credibility and self-efficacy) on consumer buying intention towards the branded product, with mediating (brand trust) and moderating effect (Persuasion knowledge) using Uses and Gratifications Theory. A total of 512 original samples were collected through purposive sampling methods and analyzed through structural equation modelling. The results reveal that credibility, trustworthiness, source credibility, and self-efficacy significantly impact brand trust,

and trustworthiness, credibility; While self-efficacy played a significant role in the social media news to build strong brand trust. The brand trust had a positive and a robust mediating effect on consumer buying intention; and Persuasion knowledge positively moderates' credibility, trustworthiness, source credibility, self-efficacy and consumer buying intention. This study provides important implications from marketing perceptive as it applies and extends the gratification theory and persuasion knowledge. Our findings are beneficial for key stakeholders of a brand that are facing serious advertising concerns due to widespread fake news.

Vedika Saxena. Corporate Cash Holdings and Share Buyback: Evidence from Emerging Markets DOI: https://doi.org/10.1177/09726527231184555

Abstract: This study evaluates corporate cash holdings (CCHs) as a determinant of share buyback for three emerging economies, India, Malaysia, and South Korea, from 2002 to 2020. We find CCH as a significant determinant of share buyback for our sample nations. Our results suggest that share buyback is a flexible way for firms to distribute excess cash across our sample nations. Our study also documents the impact of different country-level investor protection



frameworks on buybacks. A favorable relationship between a strong investor protection environment (good governance) and buyback explains the effective role of buyback in resolving agency conflicts compared to dividends.

Pratik Maheshwari. Resilient healthcare network for simultaneous product allocations during supply chain disruptions. DOI: https://doi.org/10.1080/16258312.2023.2238669

COVID-19 is responsible for medical emergencies, and uncertainty in healthcare supply chain (HSC). The HSC is struggling against the massive disruption due to the pandemic; thus, this alarming trend reinforces the need for a resilient HSC and a unique dynamic, responsive plan. The pandemic has strained hospitals and



quarantine centres, necessitating crisis management for resource allocation. Addressing HSC issues, we've meticulously analysed vehicle routing problems (VRP) and devised solutions. The proposed methodology is exploring the dynamic programming (DP) for resilient HSC. The study offers a single-vehicle routing strategy with simultaneous loading and unloading of items between the depot and N nodes (hospitals and quarantine centres) to alleviate the vulnerability of commodities and recovery of items. The implication of this work is to provide dynamics of special purpose vehicle (SPV) with two storage facilities, one dedicated to fresh healthcare products (depot to nodes) and the second dedicated to old/recyclable/disposable healthcare products (nodes to depot). Finally, utilising the DP and particle swarm optimisation introduces an innovative strategy that compares efficient routing and allocation decisions for resilient HSC. It offers practitioners guidance on optimal operational sequences, optimal cost, and computational times for SPV, enhancing HSC response capabilities during crises.
