- 3.4 Price to be quoted as per Annexure-I. GST if any, shall be paid extra as per actual.
- 3.5 The charges should be inclusive of transportation from vendor's plant/ shop to IIM Jammu and back.
- 3.6 The offer should be valid for a period of 30 days from the date of tender opening, for our acceptance.
